

Minister's Message:

I just completed a Zoom meeting with Dean Phelps, our Interim State Minister, as well as five colleagues. Dean arranged this meeting with ministers of some of the largest Disciples of Christ congregations in the region. Your congregation is one of them. This meeting was to examine some thoughts about how it might look when churches reopen in the state, especially ones like on the corner of Main and Mill. I can tell you that I have gathered my information regarding the subject, (1) from a document compiled by the Christian Church in Kentucky, (2) from the Kentucky Council of Churches, and finally from my afternoon Zoom meeting. Next week we will be discussing some of these thoughts with our Church Cabinet with the addition of several health care professionals within our congregation. The general consensus of my colleagues and a majority of their constituents is that they want to return to worship only when it is completely safe to do so. No one wants to return to worship until everyone can sing together, have communion together, and show the deepest concern for our elderly and youth. How we are presently providing worship service is being very well received. I am so grateful for our church staff and several key individuals who are making your worship experience on Sunday morning a meaningful one. I also believe we are providing a worship experience for many people who have never worshipped with us. This is a new field of evangelism. The church should always be looking for ways to recreate ourselves. I extend to you the greatest accolades for your faithful giving to the church. The receipts have been outstanding and have allowed us to be close to our church budget. Our church leadership has also been working on how to keep the expenses of next year in line with the budget of this year. I certainly appreciate the work being done by Sunday school classes and their Zoom meetings, pastoral calls by telephone made by Elders and others, youth Zoom meetings and everyone checking on one another.
