I have met with our Worship Committee this week to discuss an item that will be of concern to you. This subject has to do with the summer worship services. After much thought, we have decided to only offer one service of worship for the summer. In essence, everything will remain the same, Sunday School at 9:45 A.M. and worship at 10:45 A.M. Several reasons were considered in making this choice. It is so good to be back worshipping together as one body. After not being able to meet during the pandemic, it has been encouraging to share in one service of worship together. We are in great expectation that our crowds will continue to increase, especially if we offer only one service. It has also been brought to our attention that some elements of first service that made it so special are not available today, such as communion by intinction. We certainly believe that in due time, we will return to two services of worship, but as for now, we will celebrate with only one. Thank you for understanding the rationale for this decision. On another note I share with you a prayer provided by Week of Compassion, as it relates to the terrible tragedy in Uvalde, Texas this week:

“Lord in your mercy, hear our prayers, again and again and again and again.  
With words we’ve heard too often, and hearts unendingly broken, by violence, by terror, by anger, we pray:  
Comfort those who mourn. Be near to all who grieve. Embrace us in our fear. Draw us to your Light.  
For Uvalde, today. For too many before. For the work of grief and repentance, and change that must come next.  
Lord in your mercy, hear our prayers.”
